# **#5 SHOW CONTRACTOR / DECORATOR**

The official Show Contractor is FREEMAN. They are responsible for the following: furniture rentals (tables, chairs, etc.), draping, on-site labour and cleaning. They will also be responsible for drayage. Please see their forms on the website.

Regular Booths include – Draped backwall and sidewalls.

Note: All Sidewalls will be 3' high to the aisle. Please bring appropriate shelving, backwall, etc.

# #6 SIGNS

All booth signage is to be professionally made. We suggest you order your signs well in advance of the show.

BANNERS- Cannot always be hung over your exhibit due to the limitations of the ceiling beams. All signage and banners must be hung a minimum of 11 feet above the floor. Banners must be 3 feet less than your booth width, one sided only (unless you are an island exhibit). Signage must not appear in adjacent exhibits. Any banners or signage deemed inappropriate will be removed at the exhibitor's expense.

#### #7 MOVE-IN

#### Friday, January 14th, 2010 8:00 am - 4:00 pm

A limited number of dollies and pallet jacks are available to use on a first come, first serve basis. Security guards will be posted at move-in doors.

Exhibitors may enter the exhibit hall from 8:00 am, however all exhibits are to be setup by 5:00 pm on Friday evening.

#### **IMPORTANT:**

Lansdowne Park does not have a loading dock. All shipments must arrive on a truck with a tailgate.

#### Please Note:

Once Aisle Carpet is laid down at 3pm – dollies will NOT be permitted.

#### #8 MOVE-OUT

# Sunday, January 16th, 2010 5pm – 12 Midnight

No materials may be left on location past 12 Midnight Sunday night.

No removal or dismantling of exhibits or exhibit materials will be permitted before the end of the Show.

Exhibitors are strongly urged to remove all cartons and cases of product from the building immediately after the close of the Show.

While Show Management will take all reasonable security measures to safeguard small items, immediate removal of such items will minimize the possibility of loss from pilferage.

# **#9 SPACE APPLICATIONS**

Show Management reserves the right to accept or reject applications at any time.

PAYMENT OF EXHIBIT SPACE MUST BE PAID IN FULL BEFORE DEC. 4TH, 2010.

### **#10 ALTERATIONS TO BUILDING**

Painting, nailing, drilling, or screwing to the floor, walls or any part of the building is STRICTLY PROHIBITED except by prior written approval of both Show Management and Building Management.

# **#11 BOOTH CONSTRUCTION**

#### A. HEIGHT

Inline booths may reach a maximum of 8' in height. Island booths may be over 8' in height. Perimeter booths may be 10' in height.

#### **B. SIGNAGE**

Must be incorporated into your exhibit design and height of 8'. Signage must not appear in adjacent exhibits.

#### C. DRAPE

All booths will be supplied with 8' high draping at the back and 3' high on the sides. No draping is allowed on the aisle side of the booths. Any variation or changes in the standard draping are at the exhibitor's expense. Nothing is to be pinned or stapled to the drape – "S" hooks are available from Black Kat Enterprises in the Show Office.

# **#12 EXHIBITOR BADGES**

Please indicate how many exhibitor badges your company requires - to a maximum of 6 per 10x10 - on your Exhibitor Badge Form found on the website.

Exhibitor badges are available for pick-up at the Show Office during move-in.

# #14 SAMPLES, SOUVENIRS AND SOLIC-ITING

#### **#15 CUSTOMS**

# **#17 ELECTRICAL EQUIPMENT**

Regulations made by the Labour Electrical safety branch, provide that all electrical equipment operating at the show be approved. Equipment that is approved by the CSA and bears that association's mark of approval is acceptable to the commission.

# **#18 CLEANING**

ONLY the aisle carpet will be cleaned (vacuumed) at the end of each night. Arrangements for your own booth can be made through FREEMAN. See their forms on the Show website.

# #19 HANDLING OF EXHIBITS, MATERIALS AND EQUIPMENT

Should your display require the use of heavy duty unloading equipment, you are requested to notify FREEMAN by January 7th, 2010 so that arrangement can be made to have it available.

Costs of renting and operating such equipment must be borne by the exhibitor. Exhibitors who can supply their own trucks and dollies are urged to do so.

Black Kat Enterprises provides pallet jacks and a limited number of dollies on a first come first served basis.

#### **#20 INSURANCE**

Show Management, Sexapalooza, Lansdowne Park and the City of Ottawa will not be responsible for injury to persons, loss or damage of products, exhibits, equipment or decorations by fire, accident, theft or any other cause while in the show building or its environs.

Note: Exhibitors must consult with their own insurance broker to ensure that they are insured against all risks to either personnel or equipment and public liability.

#### **#21 SECURITY**

Security guards will be on site 24-hours a day and in the building during the opening hours of move-in, show hours and move-out.
